- 4. The Auction of said vehicles will be governed by the following conditions:-
- i. The vehicles will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by the O/o Director General of Income Tax(Inv), Mumbai.
- ii. The bidders are required to pay the Earnest Money of Rs. 5,000/- (Rupees Five thousand only) for each vehicle as listed above.
