Sub : Circulation of list of Tax Assistants of Income Tax eligible for Confirmation as on 31.12.2023– Reg.

A list of officials eligible for confirmation in the cadre of Tax Assistants as on 10.12.2023 was issued vide circular No. Pr. CCIT/Mum/Pers./Promotion/ TA-Conf. /2023-24 dated 13.12.23. In furtherance to the same, officials who have completed the probation period of two years as per the Recruitment Rules dated 18.12.2015 and have also qualified the Departmental Examination of Ministerial Staff as required vide DOPT OM dated 21.07.2014 regarding Consolidated instructions on Probation/confirmation in central services as on 31.12.23 are eligible for Confirmation in the grade.




