CORRIGENDUM

This office has issued MACPS an order under the Modified Assured Career Progression Scheme for grant of financial up-gradation to Inspectors, vide Order No. Jt.CIT(HQ)Pers./Prom./MACP Order-Insp./2022-23 dated 30/03/2023.

2. In the said order, Mr. Amresh Kumar (S/o Ram Vijay Sharma), Inspector at Sr. No.35 was inadvertently granted 3rd MACP whereas the said official was due for grant of 1st MACP. In view of the above, the words "3rd MACP" may be read as "1st MACP".

3. In addition to the above, three officials named Mr. Ratnakar Bharti, Mr. Manoj Kumar (S/o. Shree Ram Verma) and Mr. Raman Aujla were given MACPS under financial up-gradation of Inspectors w.e.f. 15.10.2022, 18.12.2022 and 24.01.2023 respectively whereas these officials have been promoted to the post of Income Tax Officer vide order No. Pr.CCIT/MUM/Admn./Prom/ITO/2022-23/925 dated 10.03.2023. Hence they are not eligible for financial up-gradation under the Modified Assured Career Progression Scheme for grant of financial up-gradation to Inspectors and the same may be withdrawn.

4. Accordingly, the MACP order for Inspectors dated 30.03.2023 stands modified.


