C I R C U L A R

Sub:-Circulation of list of officials eligible for promotion to the post of Tax Assistant for the Vacancy Year 2024 – reg.

A list of officials eligible for promotion to the post of **Tax Assistant [Level-4 of Pay Matrix (Rs.25,500 - Rs.81,100) of 7th CPC]** for the **Vacancy Year 2024** is annexed hereto.

2. As per the Income Tax Department (Group 'C') Recruitment Rules, 2015, notified on 18/12/2015 vide Notification G.S.R. 990(E) bearing F. No. HRD/CM/121/08/2014-15/Dy.No.1605/2015-Ad.VII, the feeder cadres and eligibility criteria for promotion to the post of Tax Assistant are as under:-

“Group ‘C’ employees viz. Multi Tasking Staff, Lower Division Clerk, Notice Server, Record Keeper and Senior Gestetner Operator in Pay Band-I with five years regular service in the grade including in the erstwhile Group ‘D’ having passed:

- i. *Matriculation or equivalent examination;*
- ii. *Having qualified the prescribed departmental examination for data entry skill for 5000 key depressions per hour;”*

Note:

“Where juniors who have completed their qualifying service or eligible service are being considered for promotion, their seniors would also be considered, provided they are not short of the requisite qualifying service or eligibility service by more than half of such qualifying or eligibility service or two years whichever is less and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying or eligibility service.”

3.1. The C.B.D.T., vide its letter F. No.HRD/CMD-II/122/05/Prom.-Sen.(TA)/2083 dated 28.06.2019, has clearly outlined in the reply to Para 4(ii) of the said letter that the promotion to the cadre of TA is to be given in the following manner:-

“List of eligible candidates for promotion to the post of TA has to be prepared in the following manner:-

- (I) *Prepare a list of those who fulfil ALL the following conditions given in RR:*
 - a) *5 years regular service in the concerned region in the Grade (MTS/NS/LDC/Record Keeper/Sr. Gest. Op.) including service rendered in the erstwhile Group ‘D’.*
 - b) *Having passed Matriculation examination or equivalent.*
 - c) *Having qualified the prescribed Department Examination for data entry Skill for 5000 key depressions per hour.*
- (II) *After that, arrange the list as per date of passing the data entry skill test (amongst those whose name appears in the list as step 1).”*

3.2. The C.B.D.T./ HRD, New Delhi, vide its letter F. No. HRD/CMD-II/122/5/ Prom.Sen.(TA)/1530 dated 31.05.2023 has withdrawn the clarification dated 28.06.2019. As per the clarification the relevant portion of the letter dated 31.05.2023 is reproduced as under:-

*“...3. As per Article 309 of the constitution of India, Recruitment Rules for the post of Tax-Assistant notified vide GSR 990(E) on 18.12.2015 are statutory in nature. Accordingly I am directed to convey that DPC for promotion to the post of Tax Assistant may be conducted **only by following the extant Recruitment Rules for the post of Tax Assistant.***

*4. The earlier clarification issued by the Board/ HRD in the matter such as letters of even no. dated: 13.04.2005 (issued by Ad VII, C.B.D.T based on the then RRs dated 02.09.2003 of Tax Assistant cadre), 23.05.2016, 03/04.10.2018 & 28.06.2019 **stand withdrawn with immediate effect.** It is also clarified that any action already taken as per earlier instructions of the Board/HRD in this regard shall not be altered so that settled seniority lists are not disturbed.*

5. This issues with the prior approval of the Chairman, C.B.D.T...”

3.3. In view of the above, the said eligibility list has been prepared following the Recruitment Rules only and passing of Department Examination for Data Entry Skill Test has been treated as qualifying in nature and seniority will not be based on it.

4. In view of DoP&T OM.No. 22011/4/2013-Estt. (D) dated 08.05.2017 read with CBDT instructions bearing F. No. HRD/CM/102/10/2017-18/3038 dated 05.09.2017, the crucial date for determining the eligibility for promotion for the vacancy period 2024 is 01.01.2024.

5. In view of DOPT & A.R. OM No. 36011/16/80-Estt.(SCT) dated 27.02.81, the promotion of the officials belonging to SC/ST category against vacancy reserved for SC/ST category are subject to verification of the caste status. Accordingly, all SC/ST officials featuring in enclosed eligibility list are directed to submit certified copy of Caste Certificate in the O/o. Caste Verification Cell Addl. CIT (HQ) Personnel, Mumbai for verification.

6. Objections with regard to the eligibility list annexed hereto, if any should reach this office latest by **03.11.2023.**

7. This is an eligibility list and not a seniority list and is subject to directions from higher authorities/CBDT/DOPT/Tribunal/court of law which may have a bearing on the promotion/seniority being affected by this Eligibility list.
