- NOTICE -

It is hereby informed that the following candidates, who were selected to the post of **'Stenographer'** through **'Stenographer Group 'C' Examination 2018'** conducted by Staff Selection Commission and allocated to Mumbai region, have not reported or joined this office till date.

As per the Offer of Appointment dated **23/09/2021** issued to these candidates, they were required to join as **Stenographer** in this office within two months from the date of issue of the said Offer of Appointment. However, they have not joined this office till date.

As per Rule No. 12.1.1 of the Recruitment Rules issued by the DoP&T, Government of India

"An Offer of Appointment issued by different Departments should clearly specify the period (which shall not normally exceed one or two months) after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministries/Departments but extension beyond three months should not be granted and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum of six months from the date of issue of the original Offer of Appointment."

As per Rule No. 12.1.2 of the Recruitment Rules issued by the DoP&T, Government of India

"An Offer of Appointment would lapse automatically after the expiry of six months from the date of issue of the original Offer of Appointment. If even after the extension(s), if any, granted by the department, a candidate does not join with in the stipulated time (which shall not exceed a period of six months), the offer of appointment should lapse".



In all these cases, the period of 4 months had expired on **22/11/2021** and the period of six months as mentioned in Rule 12.1.2 shall come to an end on **22/03/2022**.

First Web Notice to join this office was sent to the below mentioned candidates on **23/11/2021** and again a **second Web Notice** was sent on **20/12/2021**. However, the candidates mentioned below have still not joined. Therefore, a **Final opportunity** is being provided by way of this final web notice to candidates whose name appears in the list given below, to join this office on or before **22/03/2022**. In case of non compliance, it shall be presumed that they are not inclined to accept the offer and their candidature shall deemed to be cancelled. Their dossiers shall be returned to the concerned Staff Selection Commission office, as per extant rules.
