SCREENING CRITERIA FOR YOUNG PROFESSIONAL SCHEME 2023, MUMBAI REGION

After due diligence on the applications received, the competent authority has finalised the following screening criteria with respect to shortlisting candidates for interview:

- A. All applicants who do not meet the eligibility criteria such as Age Limit and the Essential Qualifications as specified in the advertisement will not be considered by the Committee for shortlisting.
