ADDENDUM

1. An eligibility list containing names of 48 officials, who are eligible for promotion to the post of **Sr.Tax Assistant** as on 01.01.2024 was issued vide Circular No. Pr. CCIT/Mum/Pers./Promotion/ Sr.TA-Elig./2023-24 dated 14/12/2023.

2. Subsequently, vide addendum dated 26.12.2023, a revised list of officials who cleared the Ministerial Staff Examination was released. In the said revised list it is noticed that three more officials namely Mr. Umesh Dinkar Bote, Mr. Janmesh Kumar Meena and Mr. Raju Kumar (S/o Deo Pujan Singh) also cleared the Ministerial Staff Examination 2023.
