"The CBDT instruction F.No. A-32013/3/2000-Ad. VI dated 18.07.2000, wherein the date of passing the examination was reckoned from the last date of the examination, was modified by instruction F.No. OA 542/1995/CAT Cuttack/2002/DIT/697 dated 22.05.2009.

As per the modified instruction dated 22.05.2009 it was decided that, henceforth, the effective date of passing of Examination shall be the date of declaration of result by the Directorate of Income Tax (IT) in the case of ITO/ITIs Examination."


3. The date of declaration of the result is **28.12.2022** for all purposes.
