ADDENDUM

1. An eligibility list containing names of 118 officials, who have completed the probation period of two years as per eligibility criteria and are eligible for confirmation in the cadre of **Multi Tasking Staff (M.T.S)** as on 21/01/2024 was issued vide Circular No. Pr.
