The officials who have filed application for fresh allotment of quarters/change of quarters need to file their "specific preferences (i.e. Flat no./Building/Location wise, as mentioned above)" within 7 working days /on or before 13/01/2023 from the date of notice of allotment issued (i.e., beginning from the day falling next to the date of notice) by this office, in order to be considered for allotment of quarters either in physical form in the tapal of the O/o. ITO(HQ)Admn. II, Mumbai, or vide mail at mumbai.ito.hq.admin2@incometax.gov.in.. In case they fail to file their specific preferences, they will not be considered for allotment of the above quarters. The updated list of applicants eligible for allotment of Type III Quarters is enclosed. The waiting-cum-seniority list is updated by deleting the names of the officials who have not opted for any accommodation during the past one year. The list is updated following the provision of Rule 12 of the Notification dated 16.06.2017 issued by the Ministry of Urban Development (Directorate of Estates), New Delhi.
- 3. The officials are requested to file their objection, if any, regarding the said seniority list and the vacancy status of above stated quarter. Any omission and discrepancy in date of joining may be brought to the notice of the undersigned <u>within 7</u> working days /on or before 13/01/2023 from the date of notice of allotment issued by this office directly and only in the O/o. the ITO (HQ) Admn. II, Mumbai, so that the same can be taken into consideration.

The entitlement for Type - III Quarters as per Rule 8 of the Notification dated 16.06.2017 issued by the Ministry of Urban Development (Directorate of Estates), New

Delhi and the eligibility and priority date of allotment of Type - III quarters are as under:-

# (a) Eligibility:

Type- of Residence	Grade pay (Pre-revised scale)
Type III	Rs.4200/-, Rs.4600/-, & Rs.4800/-

- **(b)** <u>Priority date</u>: For Type III category of allotment, date of priority shall be the date of joining the Government service..
- 5. It may be noted that, once this allotment process is completed there will be no carry forward of preferences. For subsequent allotment, fresh application with specific preferences would be required to be filed by the applicant.
- 6. Further it may be noted that, if any allottee fails to accept the allotment of a residential accommodation within eight days from the date of allotment of the said accommodation, or fails to take possession of that accommodation within five working days from the date of notice of allotment issued by this office from the date of receipt of the letter of authorization, he/she shall be debarred to apply for accommodation for a period of three months from the date of non-acceptance of allotment subject to payment of one month's normal licence fee for that type of accommodation [Rule 17 of the Notification dated 16.06.2017 issued by the Ministry of Urban Development (Directorate of Estates), New Delhi]. It may also be noted that, only one change is permissible in a particular type of accommodation.
- 7. It may be noted that, any misrepresentation of facts in the application would render in cancellation of allotment of quarter and would also be liable for action under the CCS (Conduct) Rules.
- 8. The applicants are requested to submit their preferences in the proforma attached alongwith this Notice.
