- 4 sets of Attestation form (11 pages in each set) (ALL SETS IN ORIGINAL with recent photograph) (PHOTOCOPY NOT ALLOWED) (Form available on www.incometaxmumbai.gov.in).
- Mark Sheet and Passing Certificate related to educational qualifications from Std. 10th to last qualified Degree.

- Proof of Age (School Leaving Certificate/Std. 10th Certificate showing the Date of Birth).
- 4. Certificate of Physical Disability (if applicable).
- 5. Service Leaving Certificate/Discharge book of Ex-Servicemen(if applicable).
- If belonging to SC/ST/OBC category, valid caste certificate issued in the Central Government format by the competent authority in this regard (two copies).
- 7. Evidence in support of claim of age relaxation, if any.
- 8. Medical Fitness Certificate issued by a Civil Surgeon/Chief Medical Officer or Medical Superintendent of any Government hospital. The Medical Fitness certificate is to be submitted only in the prescribed format (3 pages in original) that is available on <a href="https://www.incometaxmumbai.gov.in">www.incometaxmumbai.gov.in</a>.

#### **Instructions:**

- All the above mentioned documents at Sr. No. 2 to 8 should be brought in original along with a self attested photocopy of each.
- ➢ If the candidate is a Central/State Government employee, she/he may produce this letter to her/his controlling authority to enable them to provide her/his medical examination report along with police verification report, vigilance clearance, No objection certificate and character certificate (original /attested copy) obtained at the time of her/his appointment, and carry all these documents to be sent to this office through proper channel at the time of Document Verification.
- ➤ Candidate's Details Form completely filled alongwith required enclosures (form available on <a href="https://www.incometaxmumbai.gov.in">www.incometaxmumbai.gov.in</a>).
- > 5 recent photographs.
- You are instructed to bring complete address of the respective district police headquarters where you have resided for more than one year in last five years (with pin code) and also the complete address of the respective office of the concerned authority from where your caste certificate has been issued (if applicable).

As mentioned above a copy of the Attestation Form (along with instructions to fill the same), Medical Statement and Declaration Form and Candidate's Detail Form are available on the website <a href="www.incometaxmumbai.gov.in">www.incometaxmumbai.gov.in</a>. The Candidate is required to download the forms, fill them up in his own handwriting as per instructions, and carry the same with him for document verification.

Candidate should note that no travelling, boarding, lodging or other allowance shall be paid to him for verification of above-mentioned documents.
