ADDENDUM

1. An eligibility list for promotion to the posts of Assistant Manager-Cum-Storekeeper, Clerks, Halwai-Cum-Cook and Assistant Halwai-Cum-Cook was issued vide Circular dated 04.10.2023 bearing No. Pr. CCIT/Mum/Personnel/Promotion/Canteen Eligibility List/2023-24 for V.Y. 2024.

2. In the said circular, the eligibility criteria in order to be eligible for promotion to the post of Assistant Manager-Cum-Storekeeper, as stipulated in the Recruitment Rules notified on 18/11/2015, was mentioned as under:-

2.1. In compliance to the abovementioned eligibility criteria, as no official in the cadre of Halwai-Cum-Cook was fulfilling all the requisite eligibility criteria for promotion, no name was included in the eligibility list and only one official in the cadre of Clerk, viz. Mr. S. A Poojary was included in the eligibility list dated 04.10.2023 for promotion to the post of Assistant Manager-Cum-Storekeeper.

2.2. Subsequently, Mr. Vithal Tukaram Nivatkar, Halwai-Cum-Cook has intimated that he is assisting his Manager in stores management and accounts of Canteen since 15.12.2021 and would be completing 2 years of experience on 14.12.2023.

2.3. In view of the above, the name of Mr. Vithal Tukaram Nivatkar, Halwai-Cum-Cook is inserted in the eligibility list for promotion to the post of Assistant Manager-Cum-Storekeeper for V.Y. 2024 at serial no.2 after Mr. S. A Poojary, Clerk, as under:-

3. With the above insertion, the total number of officials eligible for promotion stands at 2. It is to be noted that Mr. Vithal Tukaram Nivatkar, Halwai-Cum-Cook would be considered for promotion to the post of Assistant Manager-Cum-Storekeeper for V.Y. 2024 only after submission of experience certificate by his Manager on successful completion of period of experience in stores and accounts on 14.12.2023.

4. Hence, the eligibility list for promotion to the post of to the post of Assistant Manager-Cum-Storekeeper for V.Y. 2024, as released, vide Circular dated 04.10.2023, stands modified accordingly.


