2. As per the Rule 8(3)(a) of the Notification dated 16.06.2017 issued by the Ministry of Urban Development (Directorate of Estates), New Delhi. "an applicant under this category shall be allowed to bid for one type lower accommodation than the type eligible for such."

As per the Rule, The applicants at Sr no. 1, 2 & 3 are eligible for application to Type III quarters. They are eligible to apply for Type II quarters, however they have applied for Type I quarters. Hence the preference of them has not considered and mentioned as not applicable.

3. The officials appearing at Sr. No.22 is pregnant, at Sr. No.23 is Physically and Visually Handicapped (OTH 80%) and at Sr. No.34 is Visually Handicapped (100%). The number of quarters allotted in the Calendar Year 2023 till date is only 9 and 5% of it comes out to be 0.45, Therefore no quarter has been allotted under the Medical Ground category as per the provisions of the SR 317-B-25 (now Rule 83) of the Central Govt. General Pool Residential Accommodation Rules, 2017.

4. The objections in this regard, if any, should reach this office **within 5 working days /on or before 27/02/2023** (i.e. beginning from the day falling next to the date of allotment order) so that the same is taken into consideration immediately. In case no objections are received, the allotment of quarters as above will be treated as final allotment.
