2. The official appearing at Sr. No. 6 had been allotted quarter in the month of October, 2023 and the official appearing at Sr. No. 9 had been allotted quarter in the month of September, 2023. Rule 13 of the CBDT Residential Accommodation Allotment Rules, 2023 issued vide notification dated 18.01.2023 by the Central Board of Direct Taxes(Department of Revenue) Ministry of Finance, New Delhi, states that-

"If any allottee who is allotted quarter falls to accept the allotment of a residential accommodation within eight days from the date of allotment of the said accommodation, or fails to take possession of that accommodation within five working days from the date of the of receipt of the letter of authorization, he/she shall be debarred to apply for accommodation for a period of three months from the date of non-acceptance of allotment subject to payment of one month's normal licence fee for that type of accommodation."

Since the above 2 officials had already been allotted quarter in the earlier months and have failed to take possession of the allotted quarter, they are barred to apply for further accommodation for a period of three months. In view of the same, the said officials are not considered in the present allotment.

3. The objections in this regard, if any, should reach this office within 5 working days /on or before 01/12/2023 (i.e. beginning from the day falling next to the date of allotment order) so that the same is taken into consideration immediately. In case objections are not received, the allotment of quarters as above will be treated as final allotment.
