- 2. As per CBDT Residential Accommodation Allotment Rules notified by the Central Board of Direct Taxes on 18th January, 2023, the entitlement for types of accommodation are as under:-

The applicant at Sr. No. 1 belongs to Level 4 in the pay matrix and hence is allotted quarters as per seniority. However, the applicants at Sr. No. 17 & 18 belong to Level 1 in the pay matrix and hence, are not eligible to apply for Type II quarters and therefore, not considered for allotment of Type II quarters.

3. The objections in this regard, if any, should reach this office within 5 working days /on or before 03/10/2023 (i.e. beginning from the day falling next to the date of allotment order) so that the same is taken into consideration immediately. In case objections are not received, the allotment of quarters as above will be treated as final allotment.
