2. Shri Amit Prajapati, Steno, whose name appears at Sr. No. 12 of the aforesaid list has already been allotted Quarter No. 46/1788/AH as per this office allotment order No. MUM/Pr.CCIT/Admn./Quarters/Type-11/2023-24 dated 04.07.2023. He has surrendered the quarters allotted to him. As per rule 44(2) of the CBDT Residential Accommodation Allotment Rules dated 18<sup>th</sup> January, 2023, an applicant who surrenders the quarters allotted to him shall not be considered again for allotment of accommodation at the same station for a period of one year from the date of such surrender. Hence, the official is not considered in the present allotment.

3. The objections in this regard, if any, should reach this office **within 5 working days /on or before 27/07/2023** (i.e. beginning from the day falling next to the date of allotment order) so that the same is taken into consideration immediately. In case objections are not received, the allotment of quarters as above will be treated as final allotment.
