3. The Directorate of Income Tax (Exam & OL), New Delhi has disposed off the representation with the following remarks :-

"The representations for revaluation/retotalling are rejected as it is not permitted under Rule X(a) of amended Departmental Examination Rules for ITI-2009 which says "No request shall be entertained under any circumstances for revaluation or re-totalling of the answer scripts for the objective type papers."

4. The representations regarding revision of answer keys and grace marks have been disposed off with the following remarks :-

"With the approval of the Competent Authority, answer keys of objective type papers of ITI/ITO Departmental Examination – 2022 are hereby published before declaration of the result. Any representation in respect of question and answer keys will be entertained only through Cadre Controlling Authority and only before 6 P.M. on 05.12.2022".

As per Amended Departmental Examination Rules for ITI-2009, Rule VI A for Grace Marks is as below :

A Candidate may be allowed a maximum of five grace marks in the following manner :-

- a. For the purposes of obtaining exemption from re-appearance in individual papers a maximum of two percent of the total marks of the paper shall be allowed as grace marks.*
- b. Where a candidate is fully qualifying the examination, in a year, the whole of five grace marks may be allowed in one paper subject to the condition that no grace marks have been availed in any paper in the same or previous examination in obtaining exemption from reappearing in any paper of that examination.*
- c. Where a candidate has already availed grace marks in the past in passing individual paper(s) in the same or previous examination, the grace marks already availed shall be reduced from the maximum permissible five grace marks and the balance if any, shall be allowed to the candidate."*

Candidates demanded extra grace marks for themselves, as per Rule the extra grace marks cannot be awarded to these candidates."

5. Thus, the request of the candidates who had applied for re-totalling/re-valuation/revision of answer keys/providing extra grace marks stands disposed off.
