**Sub:** Circulation of list of officials eligible for promotion to the post of Administrative Officer Grade-III for the Vacancy Year 2024 - Reg.

A list of officials eligible for promotion to the post of Administrative Officer Grade-III [Level-7 of Pay Matrix (Rs.44,900 – Rs.1,42,400) of 7th CPC] for the Vacancy Year 2024, is annexed hereto.

2. The list has been prepared keeping in view the eligibility criteria for promotion to the post of Administrative Officer Grade-III, as prescribed in the Income Tax Department Administrative Officers (Group “A” and “B” posts), Recruitment Rules, F.No.A-12018/1/2003-Ad.VI, notified on 30/12/2004. As per the said Recruitment Rules, promotions to the post are to be made from amongst Office Superintendents with three years of regular service in the grade. The relevant portion of the Recruitment Rules is as under:

NOTE:- “Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service”.

3. In view of DoP&T OM. No. 22011/4/2013-Estt(D) dated 08.05.2017 read with CBDT instructions bearing F. No. HRD/CM/102/10/2017-18/3038 dated 05.09.2017, the crucial date for determining the eligibility for promotion for the vacancy year 2024 is 01.01.2024.

4. In view of DOPT & A.R. OM No. 36011/16/80-Estt.(SCT) dated 27.02.81, the promotion of the officials belonging to SC/ST category against vacancy reserved for

SC/ST category are subject to verification of the caste status. Accordingly, all SC/ST officials featuring in enclosed eligibility list are directed to submit certified copy of Caste Certificate in the O/o Addl. CIT(HQ) Administration, Mumbai for verification.

5. Objections with regard to the eligibility list annexed hereto, if any should reach this office latest by **13.10.2023**.

6. This is an eligibility list and not a seniority list and is subject to directions from higher authorities/CBDT/DOPT/Tribunal/court of law which may have a bearing on the promotion/seniority being affected by this Eligibility list.
