Sub:-Circulation of lists of officials eligible for promotion to the post of General Manager, Deputy General Manager, Manager Grade-II & Manager-Cum-Accountant in the Income Tax Departmental Canteens, Mumbai for the Vacancy Year 2023-reg.

The eligibility criteria for promotion to the post of **General Manager, Deputy General Manager, Manager Grade-II & Manager-Cum-Accountant**, in the Income Tax Departmental Canteens, Mumbai for the Vacancy Year 2021 is prescribed in the Income Tax Department non-statutory Departmental Canteens Recruitment Rules, 2004 notified on 15/04/2004, under G.S.R. 134 by Central Board of Direct Taxes. As per the said Recruitment Rules, the feeder cadres and eligibility criteria for promotion to the abovementioned post is as under:-

3.	Manager Grade-II	Cashier or Assistant Manager-Cum-Storekeeper with at least six years' regular service in the grade. [After accepting the Sixth Pay Commission Report, the cadre of Cashier has been merged with Assistant Manager-Cum-Storekeeper]

4.	Manager-Cum-Accountant	Cashier or Assistant Manager-Cum-Storekeeper with at least six years' regular service in the grade. [After accepting the Sixth Pay Commission Report, the cadre of Cashier has been merged with Assistant Manager-Cum-Storekeeper]
