C I R C U L A R

Sub: Circulation of list of officials eligible for promotion to the Post of Inspector of Income Tax for the Vacancy Year 2024– reg.

A list of officials eligible for promotion to the post of **Inspector of Income-Tax [Level 7 of Pay Matrix (Rs. 44,900 – Rs. 1,42,400) of 7th CPC]** for the **Vacancy Year 2024** is annexed hereto.

2. The existing recruitment rule in respect of cadre of Inspector of Income Tax is issued vide F. No.48(1)/2001-A.P./DOMS/166/403 dated 04/06/2001 read with notification of CBDT bearing G.S.R.768 dated 08.09.1986 and CBDT notification bearing G.S.R. 2800 dated 20.12.1969. The feeder cadres and eligibility criteria for promotion to the post of Inspector of Income-tax and the ratio in which promotions are to be made from Ministerial Cadre and Stenographer Cadre for R.Ys. 2001-02 onwards are as under:-

“...Eligible cadres:-

Office Superintendent

Senior Tax Assistant (the merged cadre including DEO Grade C and DEO Grade B)

Tax Assistant

UDC

Steno Grade I/II/III

With three years' service in the respective grade and should have qualified the Departmental Examination for Income Tax Inspectors...”

3. In view of DoP&T OM. No. 22011/4/2013-Estt (D) dated 08.05.2017 read with CBDT instructions bearing F. No.HRD/CM/102/10/2017-18/3038 dated 05.09.2017, the crucial date for determining the eligibility for promotion for the vacancy year 2024 is 01.01.2024.
4. As per clarification issued by the Directorate of Income-tax (IT), CBDT, New Delhi, vide letter F. No. DE/Delhi/Effective Date/DIT/2011/3943 dated 22/12/2011 the effective date of passing of Examination shall be the date of declaration of result by the Directorate of Income Tax (IT) in the case of ITOs/ITIs Examination. Hence, the effective date of passing of the ITI Examination is followed in the preparation of the eligibility list.
5. In view of DOPT & A.R. OM No. 36011/16/80-Estt.(SCT) dated 27.02.81, the promotion of the officials belonging to SC/ST category against vacancy reserved for SC/ST category, if at all to be given, is subject to verification of the caste status. Accordingly, all SC/ST officials featuring in enclosed eligibility list are directed to submit certified copy of Caste Certificate in the O/o Addl. CIT(HQ) Personnel, Mumbai for verification **before 18.12.2023.**
6. Objections with regard to the eligibility list annexed hereto, if any, should reach this office **latest by 18.12.23.**
7. This is an eligibility list and not a seniority list and is subject to directions from higher authorities/CBDT/DOPT/Tribunal/court of law which may have a bearing on the promotion/seniority being affected by this Eligibility list.
