- 3. In view of DoP&T OM. No. 22011/4/2013-Estt(D) dated 08.05.2017 read with CBDT instructions bearing F. No. HRD/CM/102/10/2017-18/3038 dated 05.09.2017, the crucial date for determining the eligibility for promotion for the vacancy period 2024 is 01.01.2024.
- 4. In view of DOPT & A.R. OM No. 36011/16/80-Estt. (SCT) dated 27.02.81, the promotion of the officials belonging to SC/ST category against vacancy reserved for SC/ST category are subject to verification of the caste status. Accordingly, all SC/ST officials

featuring in enclosed eligibility list are directed to submit certified copy of Caste Certificate in the O/o Jt. CIT(HQ) Personnel, Mumbai for verification.

- 5. Objections with regard to the eligibility list annexed hereto, if any should reach this office latest by <u>25.10.23</u>.
- 6. This is an eligibility list and not a seniority list and is subject to directions from higher authorities/CBDT/DOPT/Tribunal/court of law which may have a bearing on the promotion/ seniority being affected by this Eligibility list.
