As per the issued Offer of Appointment dated 28/12/2022, they were required to join as Tax Assistant in this office within two months from the date of issue of the said Offer of Appointment. However, they have not joined this office till date.

As per Rule No. 12.1.1 of the Recruitment Rules issued by the DoP&T, Government of India


"An Offer of Appointment issued by different Departments should clearly specify the period (which shall not normally exceed one or two months) after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministries/Departments but extension beyond three months should not be granted and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum of six months from the date of issue of the original Offer of Appointment."

As per Rule No. 12.1.2 of the Recruitment Rules issued by the DoP&T, Government of India

"An Offer of Appointment would lapse automatically after the expiry of six months from the date of issue of the original Offer of Appointment. If even after the extension(s), if any, granted by the department, a candidate does not join within the stipulated time (which shall not exceed a period of six months), the Offer of Appointment should lapse".

Thus, a **first opportunity** to join this office is being given to them. In case, they do not comply by 27/03/2023, it will be presumed that they are not interested in the Offer and their candidatures will be cancelled and also their dossiers will be returned to the concerned Staff Selection Commission office, as per the extant rules.
