

The officials appearing at Sr. No.5 is Visually Handicapped, at Sr. No.32 is Hearing Handicapped, at Sr. No.41 is Orthopedically Handicapped, at Sr. No.44 is Orthopedically Handicapped, at Sr. No.50 is Orthopedically Handicapped, at Sr. No.62 is Visually Handicapped and Sr. No.65 is Physical Handicapped. The number of quarters allotted in the Calendar Year 2023 till date is only 12 and 5% of it comes out to be 0.60, Therefore no quarter has been allotted under the Medical Ground category as per the provisions of the SR 317-B-25 (now Rule 83) of the Central Govt. General Pool Residential Accommodation Rules, 2017.

3. The objections in this regard, if any, should reach this office **within 5 working days /on or before 30/05/2023** (i.e. beginning from the day falling next to the date of allotment order) so that the same is taken into consideration immediately. In case objections are not received, the allotment of quarters as above will be treated as final allotment.
