ORDER

The Departmental Examination for Ministerial Staff - 2022 was conducted in the month of October 2022. The result was declared vide office order No. Jt.CIT(HQ)Pers./Exam/M.S. Result-2022/2022-23 dated 22.12.2022.

2. Subsequently **97** candidates had applied for re-totalling of their marks in various papers. In all, **133** Answer Scripts were checked for re-totalling of marks. The Answer Scripts of the candidates for papers mentioned in their representations have been examined carefully and the marks totalled again.

3. No mistakes in recounting of marks or omission of valuation of any answer or part thereof have been found in the following cases:

4. The recounting has resulted in change of marks of **14 candidates** as per the details in **Annexure 'A'** to this order.

5. Remarks to Annexure 'A':

The details of the result of the candidates whose marks have changed due to re-totalling is as follows :-

- i) The candidate at Sr.No.1 bearing **Roll No. 84**, Shri Aniket Soni, Stenographer, (Category-General) whose revised marks after re-totalling in Paper 3- Office Procedure (without book) arrive at 59 (51+8=59). The candidate has secured 46.2% marks in aggregate. Consequent to this he is eligible for obtaining grace of one mark in Paper 3 Office Procedure (without book), viz (59+1= 60). He is declared **Pass in Paper 3 Office Procedure (without book) and his overall result changes to "PASS under Rule VI(1)(c)".**
- ii) The candidate at Sr.No.2 bearing **Roll No. 190**, Shri Bobby, Tax Assistant, (Category-SC) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 25 (23+2=25). He is declared Fail in Paper 3 Office Procedure (without book) and his overall result remains unchanged that is **FAIL**.
- iii) The candidate at Sr.No.3 bearing **Roll No. 196**, Shri Chetan Jesing Rathod, MTS, (Category-SC) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 28 (27+1=28). He is declared FAIL in Paper 3 Office Procedure (without book) and his overall result remains unchanged that is **FAIL**.
- iv) The candidate at Sr.No.4 bearing **Roll No. 270**, Shri Hemant Pal, Tax Assistant, (Category-General) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 26 (22+4=26). He is declared FAIL in Paper 3 Office Procedure (without book) and his overall result also remains unchanged that is **FAIL**.

- v) The candidate at Sr.No.5 bearing **Roll No. 313**, Ms. Komal, Multi Tasking Staff, (Category-General) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 14 ($11+3=14$). She is declared FAIL in Paper 3 Office Procedure (without book) and her overall result also remains unchanged that is **FAIL**.
- vi) The candidate at Sr.No.6 bearing **Roll No. 369**, Ms. Mansha Kumari, Stenographer, (Category-General) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 60 ($59+1=60$). **She is declared PASS in Paper 3 Office Procedure (without book) but her overall result remains unchanged that is FAIL.**
- vii) The candidate at Sr.No.7 bearing **Roll No. 416**, Shri Narendra Singh, Multi Tasking Staff, (Category-General) whose revised marks after re-totalling in Paper 2 Office Procedure (with books) arrive at 35 ($34+1=35$). He is declared FAIL in Paper 2 Office Procedure (with books) and his overall result also remains unchanged that is **FAIL**.
- viii) The candidate at Sr.No.8 bearing **Roll No. 480**, Ms. Pooja Amar Shetty, Tax Assistant, (Category-General) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 41 ($37+4=41$). She is declared FAIL in Paper 3 Office Procedure (without book) and her overall result also remains unchanged that is **FAIL**.
- ix) The candidate at Sr.No.9 bearing **Roll No. 737**, Shri Subodh Kant, Tax Assistant, (Category-General) whose revised marks after re-totalling in Paper 3, Office Procedure (without book) arrive at 55 ($54+1=55$). The candidate has secured 52.8% marks in aggregate. Consequent to this he is eligible for obtaining grace of five marks in Paper 3 Office Procedure (without book), viz ($55+5= 60$). He is declared **Pass in Paper 3 Office Procedure (without book) and his overall result changes to "PASS under Rule VI(1)(c)".**
- x) The candidate at Sr. No.10 bearing **Roll No. 775**, Ms. Tejashri T. Ghadigaonkar, Tax Assistant, (Category-General) whose revised marks after re-totalling in Paper 3 Office Procedure (without book) arrive at 31 ($30+1=31$). She is declared FAIL in Paper 3 Office Procedure (without book) and her overall result also remains unchanged that is **FAIL**.
- xi) The candidate at Sr.No.11 bearing Roll No.782, Shri Umesh Dinkar Bote, Tax Assistant (Category-ST) whose revised marks in Paper 3 Office Procedure (without book) arrive at 45 ($43+2=45$). He is declared FAIL in Paper 3 Office Procedure (without book) and his overall result also remains unchanged that is **FAIL**.
- xii) The candidate at Sr.No.12 bearing Roll No.782, Shri Umesh Dinkar Bote, Tax Assistant (Category-ST) whose revised marks in Paper 4 Practical Test arrive at 48 ($38+10=48$). He is declared FAIL in Paper 4 Practical Test and his overall result also remains unchanged that is **FAIL**.

- xiii) The candidate at Sr.No.13 bearing Roll No.783, Shri Umesh Pandhari Gautam, Tax Assistant (Category-General) whose revised marks in Paper 4 Practical Test arrive at 40 (30+10=40). He is declared FAIL in Paper 4 Practical Test and his overall result also remains unchanged that is **FAIL**.
- xiv) The candidate at Sr.No.14 bearing Roll No.835, Shri Yogendra Kumar, Multi Tasking Staff (Category-General) whose revised marks in Paper 3 Office Procedure (without book) arrive at 30 (29+1=30). He is declared FAIL in Paper 3 Office Procedure (without book) and his overall result also remains unchanged that is **FAIL**.
